inging in a new year sparks a sense of renewed hope and optimism about the future. As the president & CEO of Jackson Energy, for me, it's a time to reflect on where we are and where we're going. At the heart of this reflection, I think about ways we can better serve you, the members of the cooperative.

Our team at Jackson Energy is always looking ahead, exploring ways to innovate and utilize new technologies to improve our services. As our nation increasingly relies on electricity to power the economy, keeping the lights on has never been more important. We're committed to powering—and empowering—our community at a cost local families and businesses can afford.

A critical component of reliable power is the mix of energy resources used to generate the electricity that keeps the lights on across our service territory. In addition to managing a reliable energy mix, Jackson Energy is using technology to enhance our local grid, limit service disruptions and improve outage response times.

Advanced metering technology, also known as AMI, enables two-way communication between the co-op and members. In the event of a power outage, AMI helps pinpoint the exact location of the outage and can even analyze damaged or tampered meters. AMI helps Jackson Energy save money with real-time data, and ultimately improves power reliability for our entire community.

Proactive tree clearing is another way we limit service disruptions. Scheduled clearing keeps power lines clear from overgrown limbs that are likely to fall. Drone inspections of lines and vegetation have allowed us to reduce labor and equipment costs while bolstering reliability. Through the use of small drones, we can accurately monitor the health and growth of trees and identify potential problems. As technology advancements become more accessible, we anticipate using advanced mapping software to better maintain the environment while providing more reliable service.

One of the best methods for improving our services to you is monitoring trends and leading practices from other electric co-ops in Kentucky and across the country. Learning from other co-ops is one of the many benefits of the cooperative business model because for us, it's about cooperation, not competition.

As we turn our focus to 2024, Jackson Energy will continue working to provide the reliable, affordable electricity you expect and deserve—for today and tomorrow.

Safety is our top priority

lineworker's job is tough, it's no secret. But it's essential. The job of our lineworkers requires physical strength and endurance, especially during the long hours of power restoration in extreme weather conditions.

Yet for all of the physical strength required in this profession, the mental strength and focus of our lineworkers are crucial. Working with high-voltage lines on a daily basis requires extraordinary attention to detail and safety, as someone's life is on the line.

It's for this reason that Jackson Energy insists on thorough and constant safety training.

Safety is the top priority at Jackson Energy, and our lineworkers must train extensively on safety scenarios to be better prepared for any situation that may occur at any time. This includes worst-case scenarios like an injured or unconscious lineworker at the top of a pole or in a bucket high in the air.

Bucket and pole-top rescue training is a required exercise that each lineworker must complete annually with the hope of never needing to use it.
